ENTRY INFORMATION

The entry fee is \$35.00 per single-dog team, \$40 per brace.

Entry is limited to seventeen (17) teams total on Friday and on Saturday, whether entered in Novice Draft, Open Draft or Brace Draft.

Bitches in season may compete either day, after all male dogs have completed the entire test (including the freight haul). Bitches in season must be contained inside a cabin or outside the group camp area until all male dogs have completed the entire test.

If more than 17 entries are received for Friday or Saturday, a random drawing will be held within 48 hours of the closing time. Although it is the policy of the GSMDC to invite and encourage any dog to enter a GSMDC draft test, GSMDCs will be given preference over other breeds. All entrants will be notified by mail of their entry status. Alternates will also be drawn and may compete in the absence of regular entries.

Entries close at the Test Secretary’s address on Friday, October 26, 2018, at 5:00 pm. Please type or print legibly when filling out the entry form and remember to include your telephone number and/or e-mail address. Checks should be made payable to: Southbound GSMDC Club. The Draft Test Secretary must be advised of plans to advance a dog or brace to Open Class no later than 7:00 a.m. of the day of the show in question.

Entered dogs must be 18 months or older on the day of the draft test.

Bitches in season may compete either day, after all male dogs have completed the entire test (including the freight haul). Bitches in season must be contained inside a cabin or outside the group camp area until all male dogs have completed the entire test. Please note on your entry whether your bitch might be in season so the run order can be arranged in advance.

No dogs belonging wholly or in part to the draft test judges, or to any member of their immediate family, may compete.

The Basic Control Exercise shall be waived for dogs that have earned an AKC Companion Dog (CD) title IF a copy of the CD title certificate is sent with the entry form. In the event the CD requirements were met, but the title certificate has not yet been received, the entrant may so state on the form and in a separate letter attached to the entry. If the dog passes the draft test, the NDD or DD title and certificate will be withheld until after the Draft Work Committee (DWC) Chairman receives a copy of the CD title certificate.

Handlers must provide the draft rig. Any of the following draft rigs may be used: cart, wagon, sled, toboggan, or travois. Each of these must be equipped so that the draft rig cannot run up on the dog when hauling downhill.

The handler selects and provides appropriate freight load for the apparatus and the dog. Entrants are responsible for obtaining the GSMDCA Draft Test Regulations and being familiar with them.
